WHAT IS JUDI'S PLACE FOR KIDS?

Judi's Place for Kids, Inc. is one of fifteen Children's Advocacy Centers across the Commonwealth of Kentucky. Judi's Place, a nationally accredited and recognized program, exists to bring hope and healing to victims of child abuse and their nonoffending families. Our agency serves the counties of Pike, Floyd, Johnson, Martin, and Magoffin from our two offices located in Pikeville and Prestonsburg.

Our small staff of thirteen amazing individuals spends every day interacting with wonderful children who have had unthinkable things happen to them. In the past 12 months alone our centers have served over 450 children who have been victims of abuse or neglect. Services at our offices include Forensic Interviews, Medical Exams, Advocacy Services, and Trauma Therapy. We also spend time in the community to raise awareness for the issues of child abuse and to provide prevention education to help stop it. In 2023 we visited students at 10 different individual schools as well as teachers and administrators from 5 different school districts. Our staff works incredibly hard, but it ultimately takes an entire community working together to build a culture of prevention to keep our kids safe.

As you may expect, organizations like Judi's Place rely heavily on outside funding support to be able to function. Some of this outside support comes from local, state, and federal funding, but ultimately without the support of individuals in our community as well as partnerships with the many great companies, agencies, and organizations throughout Eastern Kentucky, we cannot do what we do. Because of this need, we place a heavy emphasis on our two major fundraisers throughout the year: our Run With Courage 5K in the Spring and our Storybook Gala in the Fall.

Last year's 5K and Gala combined raised over \$45,000 for Judi's Place for Kids. The money raised through these events goes directly towards raising our capacity to serve and support victims of abuse and their nonoffending family members.
